The subject training provides employees with basic skills that enable them to collect locational data using handheld GPS/GNSS (Global Positioning System/Global Navigation Satellite System) receivers.

The data to be collected will include unique environmental features such as wetland boundaries, stream channels, other waters, as well as associated surface and subsurface drainage and stormwater management systems. Data collected is utilized in analysis and design to help address stormwater issues.
