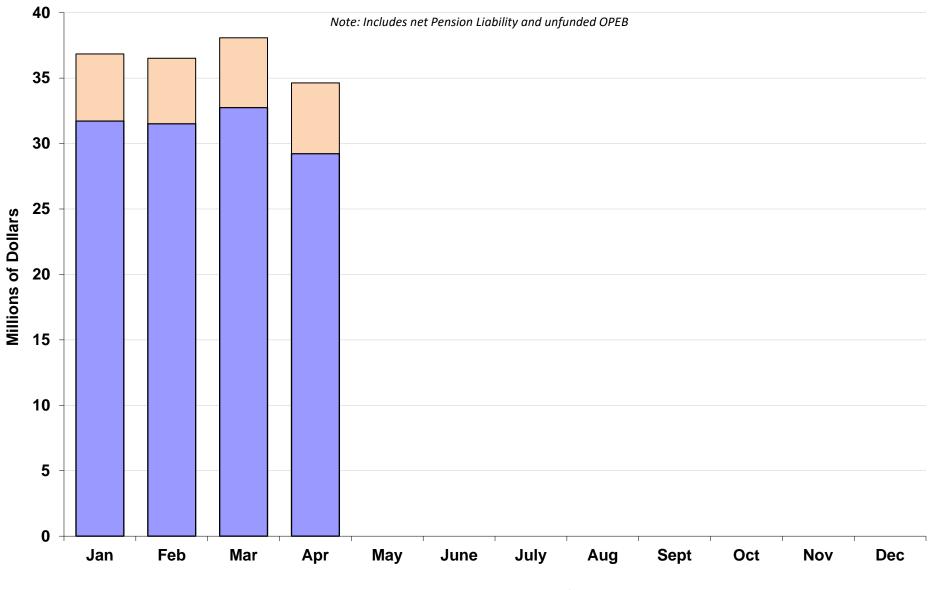

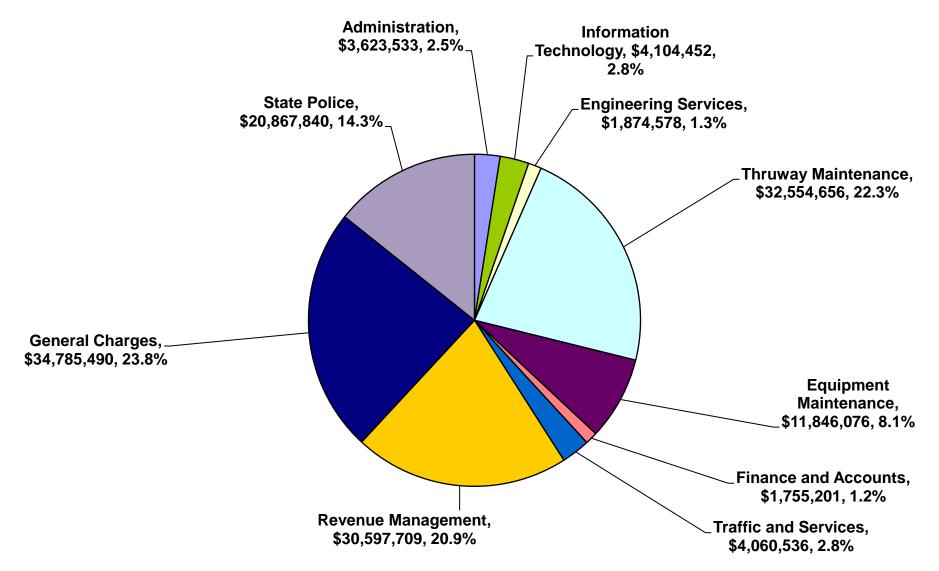

2023 YTD Operating Expenses



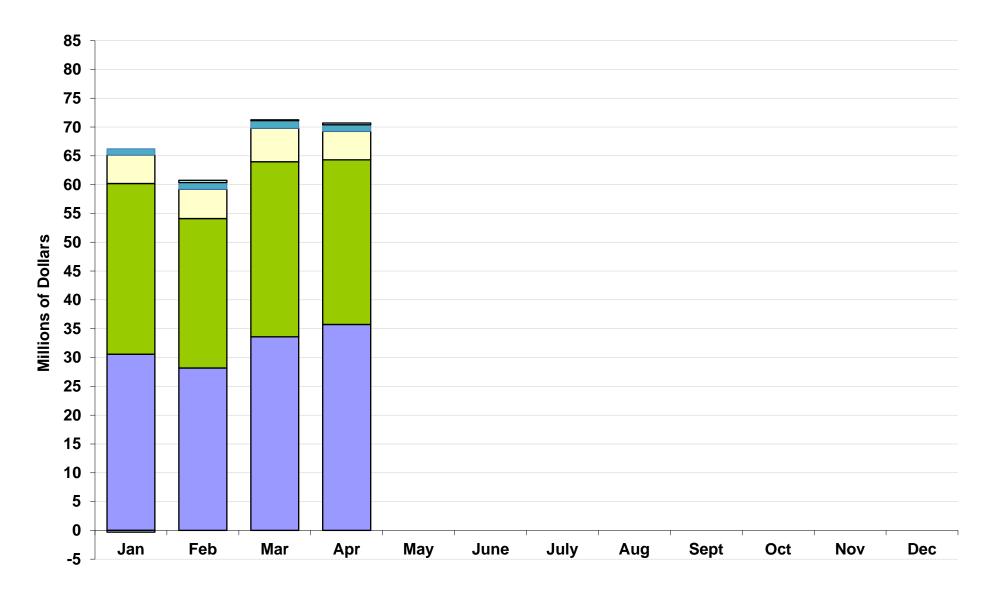

2023 YTD Operating Revenues



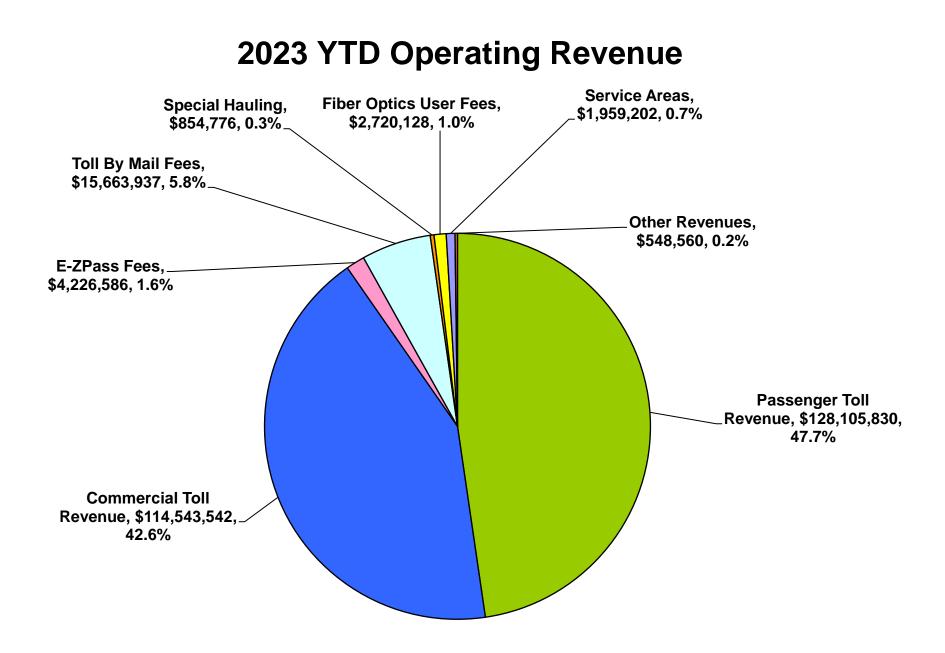

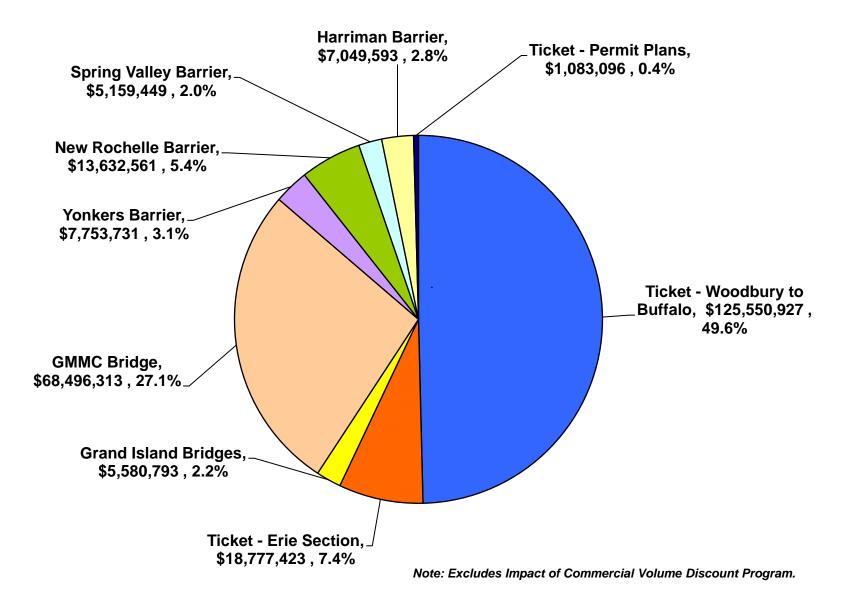

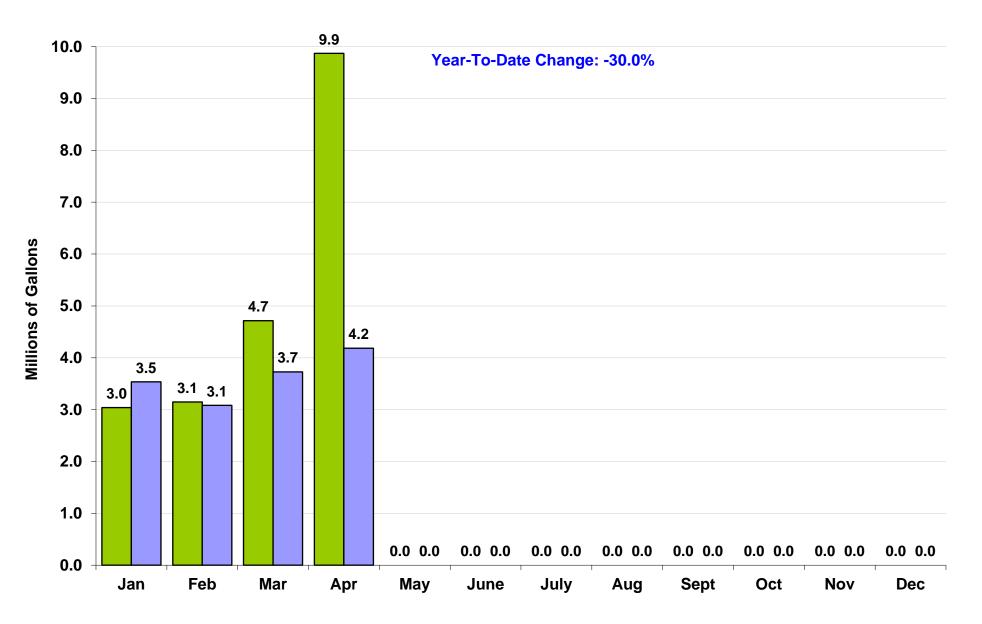

2023 YTD Toll Collections, By Location

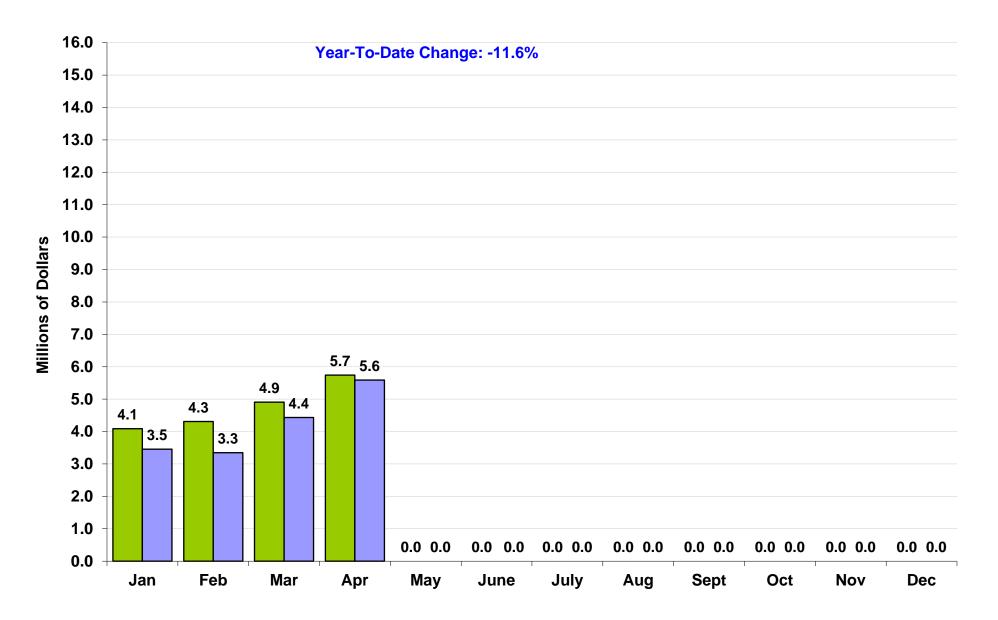


Fuel Deliveries to Service Areas

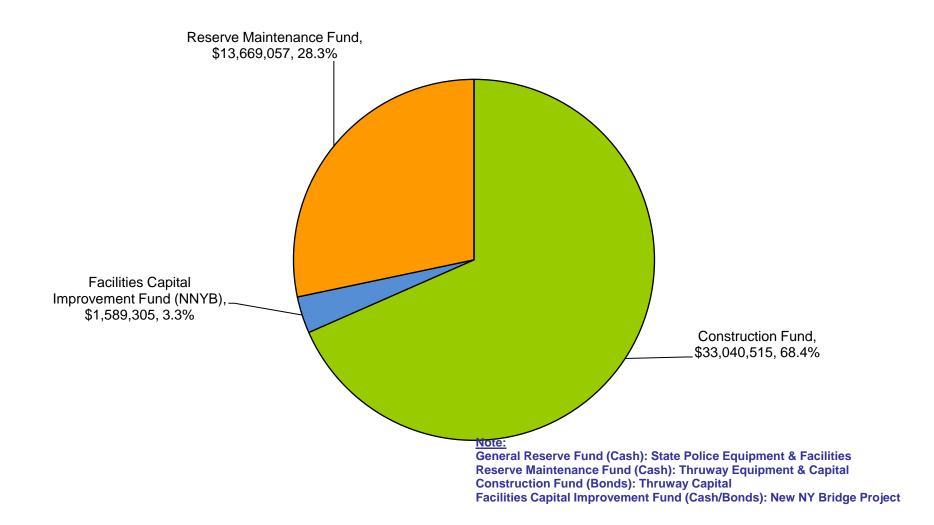
Restaurant Sales at Service Plazas

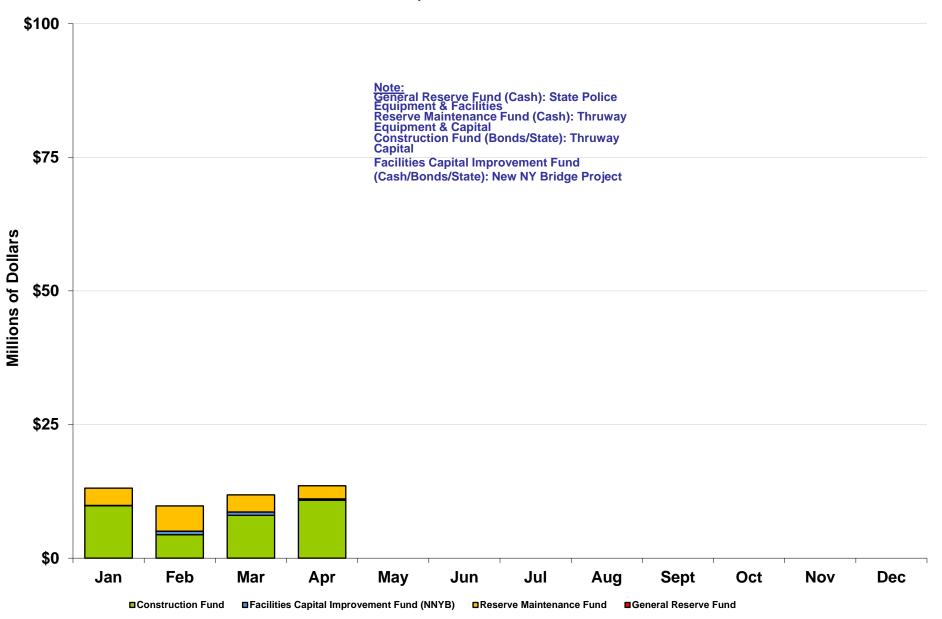
2023 YTD Capital Program Expenses, by Fund

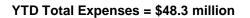


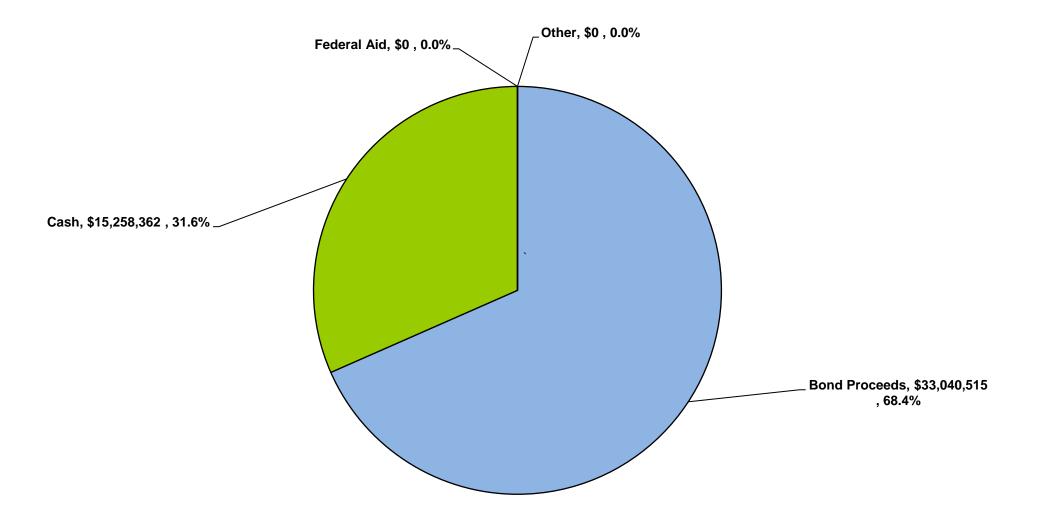
2023 YTD Capital Program Expenses, By Fund

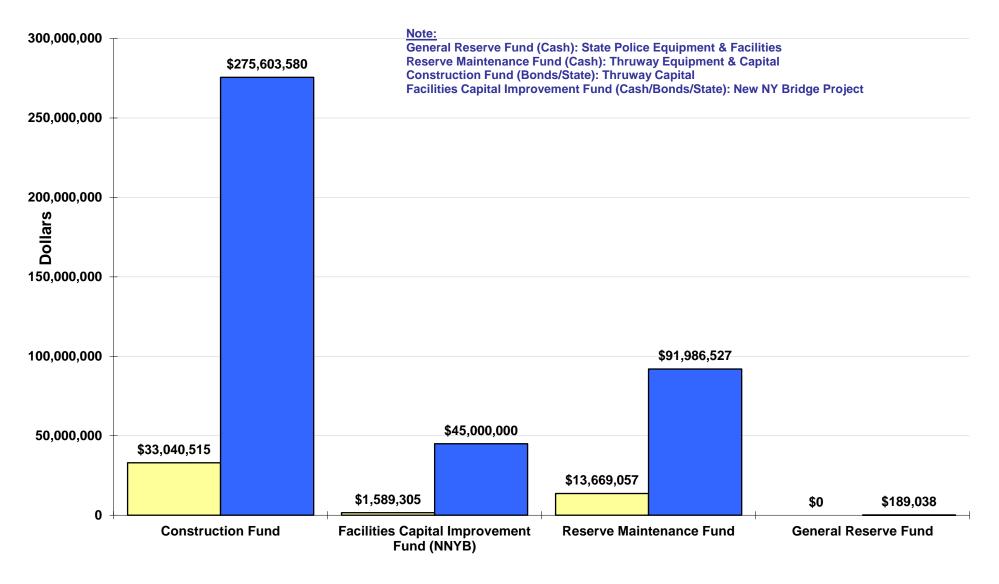
2023 YTD Capital Funding Sources





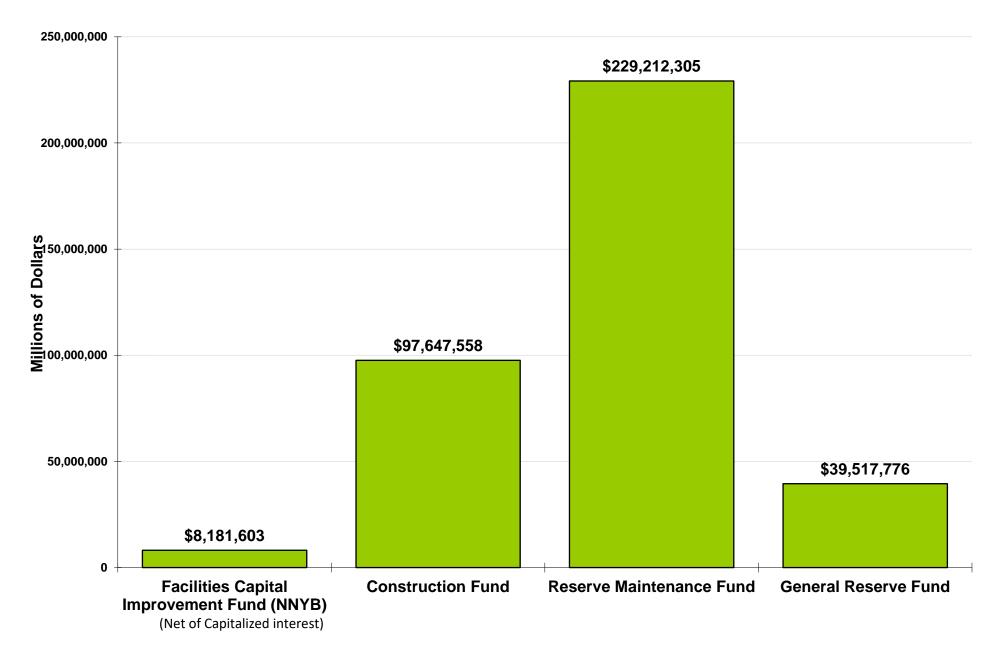
2023 YTD Capital Expenses, By Fund

2023 Capital Fund Balances at End of Month

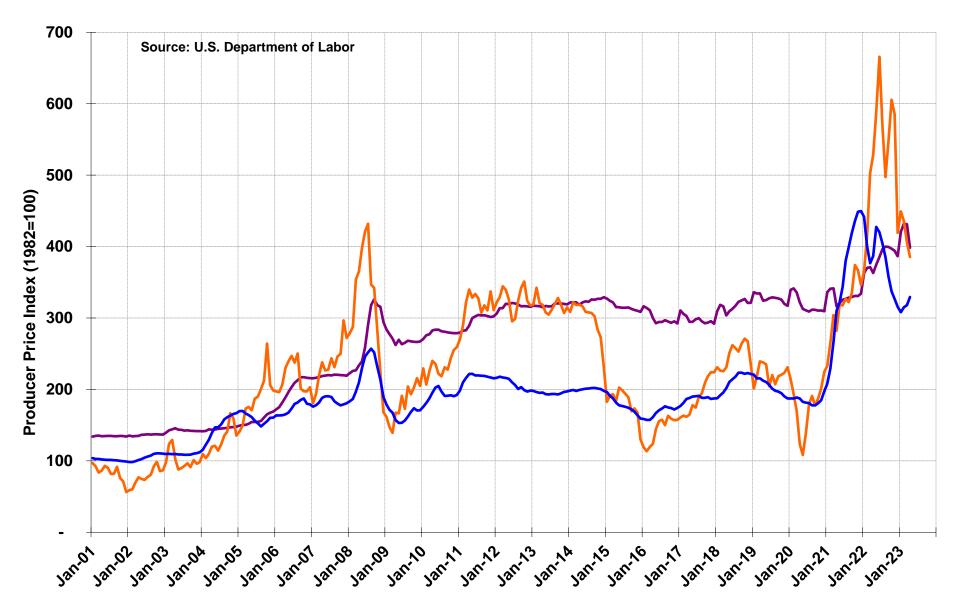


Producer Prices: Construction Inputs

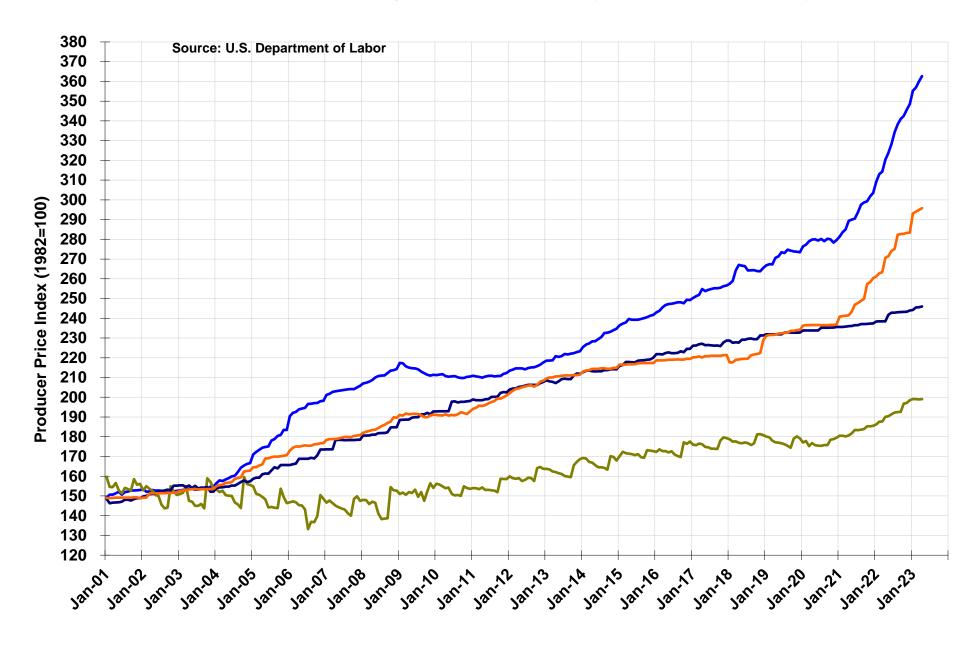

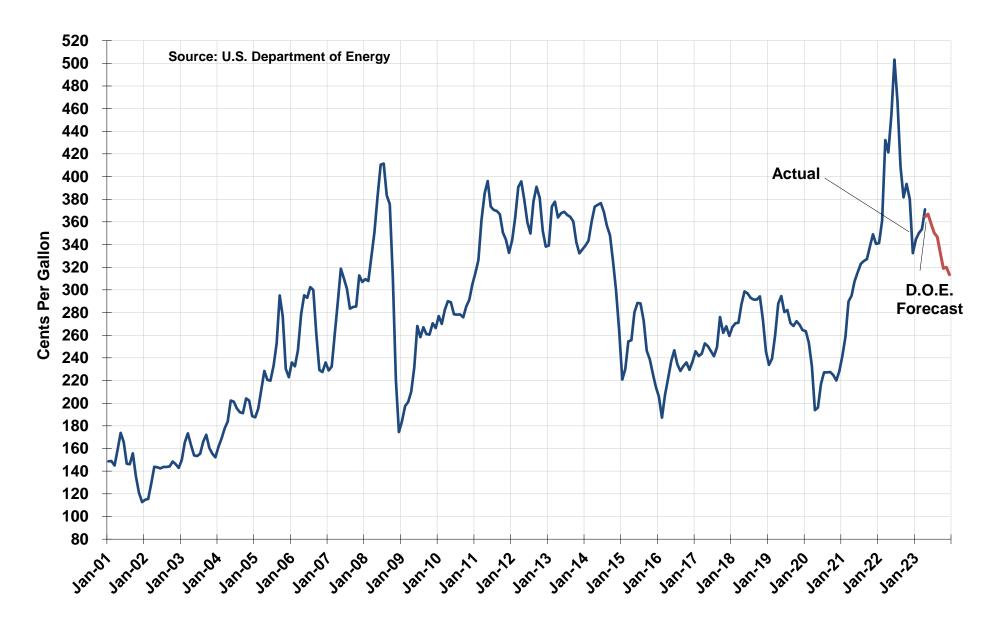

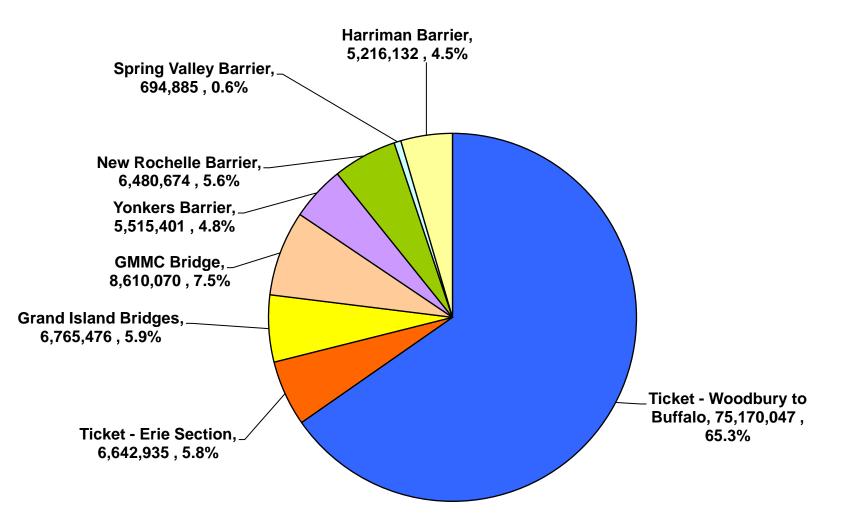
