28. CONTRACT DOCUMENTS PART 3 – PROJECT REQUIREMENTS, SECTION 1.5 DESIGN CODES AND MANUALS & SECTION 9 GEOTECHNICS  
Would the Authority please identify, as per AASHTO, the bridge operational category for the 7 sites as “Critical, Essential or Other”?

**Answer:** BINS 1020079, 5516071, 5516072, 5009929, and 5510130 are critical. BIN 5510090 is essential. BINS 5512790 and 5512980 are other. This information will be provided in the Final RFP.

29. CONTRACT DOCUMENTS PART 3 – PROJECT REQUIREMENTS, SECTION 10.3 STRUCTURES DESIGN REQUIREMENTS  
In comparing Section 7.22.5 of the *Thruway Structures Design Manual* to Section 10.3.1.D of the Project Requirements, do the project's additional thickness requirements for uncoated weathering steel apply to rolled shapes?

**Answer:** Yes, the designed rolled section requires modification.

30. REFERENCE DOCUMENTS - BIN 1020079 (I-90 over Mohawk Street)  
In the provided survey files (*1020079 Survey Files 07-19-17*), ROW information is included in both the base mapping DGN and a separate ROW DGN. However, the two sets of ROW lines do not match each other and have a horizontal shift between them. Would the Authority please clarify which is the correct ROW information?

**Answer:** The separate ROW DGN have been reposted in the correct spatial location.

31. CONTRACT DOCUMENTS PART 3 – PROJECT REQUIREMENTS, SECTION 10.3 DESIGN REQUIREMENTS FOR BIN 1020079; REFERENCE DOCUMENTS  
If available, would the Authority please provide for Proposer information, as-built plans for the existing flood protection system, such as details of the concrete supports, anchors and metal plates?

**Answer:** We are acquiring the record plans and they should be posted within a week.

32. REFERENCE DOCUMENTS - BIN 5510090 (Interchange 35 Ramp over I-90)
