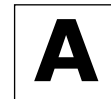

This LCV/TANDEM OPERATIONS PERMIT is granted to: \_\_\_\_\_

hereinafter referred to as the Permittee, to engage in operations with longer combination vehicle/tandem units consisting of vehicles or equipment owned by or under the control of the Permittee, on the New York State Thruway System, subject to the following conditions and those included in the LONGER COMBINATION VEHICLE (LCV)/TANDEM PROVISIONS (TAP-602), hereinafter referred to as the LCV/Tandem Provisions, to which are made a part hereof.

- In consideration of the Authority's granting this Permit, the undersigned Permittee agrees to assume all responsibility and liability for damages to persons or property that may arise from or out of, or be in any way connected with movements of the vehicles permitted hereunder, whether occasioned through the Permittee, his or her agents or employees, or from any other cause whatsoever, and to save harmless from any suit, action, or other claim whatsoever in any way connected therewith the New York State Thruway Authority, the State of New York, and their officers, agents, and employees, whether or not acting in their official capacities as such. This Permit is valid only provided there has been previously filed with and approved by the Authority a Public Liability Insurance policy affording coverage as outlined in the LCV/Tandem Provisions.
- The Authority may revoke or temporarily suspend at will any permit issued for the operation of LCVs/tandems on the Thruway System, at its sole discretion, as it determines is the best interest of the Authority. Failure to pay any required tolls and/or fees may result in suspension or revocation of company certification or LCV/Tandem Permit. The issuance of such a permit confers no property right whatsoever upon the Permittee or any other person or entity. The Authority also specifically reserves the right to amend or repeal the LCV/Tandem Provisions pursuant to which such Permit has been issued, at its sole discretion, in the exercise of its police powers or any other powers which it may possess.
- If the Authority shall temporarily suspend LCV/tandem operations at any time for any reason, including reasons of inclement weather, construction or other conditions, the instructions of the Authority and of the State Police shall be complied with immediately.  
  
This Permit shall not be valid until there are on file with the New York State Thruway Authority in approved form:
  - A list of descriptions of all tractors, lead trailers, and dollies which have been approved by the Authority for use in the LCV/tandem operations.
  - A list of all registered drivers who will operate or assist in the operation of LCVs/tandems, and to whom Special Permit To Operate LCV/Tandem Vehicles cards have been issued.
  - A policy of insurance as specified in 1. above.
- Except as noted herein and in the LCV/Tandem Provisions, all Rules and Regulations governing the use and occupancy of the Thruway System shall apply to the operation of LCV/tandem units on the Thruway System.

**Section II Certification Covering LCV/Tandem Operations**

The Permittee certifies that: (A) LCVs/tandems will not exceed maximum gross weight of \_\_\_\_\_ pounds, overall length of \_\_\_\_\_ feet \_\_\_\_\_ inches and that the maximum gross weight of the individual units and the maximum gross weight on axles of the individual units used in such combinations will not exceed the limits set forth in the Authority's LCV/Tandem Provisions, and (B) all of the vehicles and equipment used will be inspected, maintained, and operated in strict accordance with the terms and conditions of this Permit, the Authority's LCV/Tandem Provisions, and all applicable laws, rules, and regulations.
